**AGREEMENT TO PURCHASE AN ENTIRE PRIVATE SELECT BARREL FROM THE IDAHO STATE LIQUOR DIVISION  
(RETAIL CUSTOMER BARREL)**

This Agreement to purchase an entire barrel of \_\_\_\_\_ "by the barrel" from the Idaho State Liquor Division ("ISLD") is entered into this \_\_ day of \_\_ 20\_\_, between \_\_\_\_\_ ("Retail Customer"), as guarantor(s) of performance, and in their personal capacity (for purposes of this Agreement, all collectively referred to as \_\_\_\_\_).

\_\_\_\_\_ and the Idaho State Liquor Division (ISLD) agree as follows:

1. The Retail Customer agrees to purchase one (1) private select barrel selected through \_\_\_\_\_, identified as \_\_\_\_\_, consisting of approximately \_\_\_\_ 750ml bottles and packaged as \_\_\_\_ cases. This purchase is made in its entirety and includes all bottles/cases yielded from the selected barrel.
2. The ISLD agrees to issue a purchase order (PO) to the supplier **only after receiving full payment, including sales tax**, from the Retail Customer for the entire barrel.
3. Retail Customer must remove the product from the designated ISLD retail store within **ten (10) business days** of delivery to: \_\_\_\_\_.
4. **No additional cases from the barrel will be held back** by ISLD for retail sale or for distribution to on-premise licensees. The entire yield from the barrel is committed solely to this purchase.
5. If the Retail Customer intends to split the inventory with a licensed account or other affiliates, a **separate agreement must be executed with ISLD prior to the PO being issued**.
6. The ISLD retail store is **not responsible for distributing bottles** to customer affiliates, partners, or other third parties after the product is delivered and paid in full.
7. All individual bottles resulting from the barrel selection are for **personal use only** and **may not be re-sold** by the Retail Customer.
8. All applicable **federal and state laws and regulations** regarding the purchase, possession, and consumption of spirits apply.
9. Product from the selected barrel will include the following identification on the label:
